The first segment of the code (AA + NNNN) is instead descriptive of the category of article (measuring spoon, dosing syringe...) and of the type of technology used to obtain the finished article (injection, assembly, decoration...).

The second segment, on the other hand, concerns customizations or specific characteristics (for example in terms of type of packaging, custom decoration for the customer...).
